Datwyler AGM approves all Board proposals

On Tuesday, 23 April 2013, Dätwyler Holding Inc. held its 55rd Annual General Meeting at the theatre (uri) Tellspielhaus in Altdorf. The shareholders attending the meeting approved all proposals put forward by the Board of Directors.

In view of the promising perspectives and solid profitability, the Annual General Meeting declared an increased dividend of CHF 2.60 (previous year CHF 2.20) per bearer share and CHF 0.52 (previous year CHF 0.44) per registered share. This represents a payout ratio of 31.8% (previous year 35.3%). The dividend will be paid from 30 April 2013 upon presentation of Coupon No. 6.

Furthermore, the Annual General Meeting elected Gabi Huber as a new director for a four-year term. Gabi Huber holds a doctorate in law and is a member of the National Council. After 19 years of membership, Franz Steinegger has stepped down from Datwyler's Board having reached retirement age. Ulrich Graf, the president of the Datwyler Board, honoured the contributions Franz Steinegger made and welcomed Gabi Huber as the first women to the Datwyler Board.
