

The Verdict

atwyler is shortlisted in our Environmental Impact category this year for various initiatives it has taken to reduce its carbon footprint. Principal among these was as a founding member of the Alliance to Zero initiative, which brings together eight companies from across the pharmaceutical supply chain in an effort to comply with a target of net zero emissions by 2030.

The company has already made strides towards this goal transitioning a number of its production plants to renewable electricity including those in Pregnana, Montegaldella, Viadanica, and Karlsbad-Itterbach. With this and other moves the company suggests it has reduced emissions by 12,200 tonnes per year from 2021 and that 40% of its total electricity consumption now comes from renewable energy sources.



Alliance to Zero

The newly founded foundation is aimed at facilitating the transition of the pharma sector to comply with net-zero emissions and is in line with the Paris Climate Agreement.

Sharp, Harro Höfliger, Schreiner MediPharm, Körber Pharma, Schott, Health Beacon, Datwyler, and Ypsomed are all part of the founding members of the alliance. All share the view that collaboration across the pharmaceutical supply chain is needed urgently to reduce the manufacturing emissions footprint.
